SERVICE LEVEL AGREEMENT (SLA) EXTENSION BETWEEN DEPARTMENT AND MUNICIPALITY

The Department is the principal party in the provision of Registering and Testing Authority functions (Motor Vehicle Registering Authority (MVRA); Driving License Testing Centres (DLTCs) and Vehicle Testing Stations (VTS's). The Municipalities provide these functions to the public as agents of the Department in terms of the National Road Traffic Act and the conditions set out in the Service Level Agreement.

The SLA with Sedibeng is still valid and terminates on the 17 December 2017 and the Department propose the extension of the SLA to 17 December 2018 due to:

- ✓ The finalisation of the agency fee review structure and negotiations thereof.
- ✓ Review and development of the Best Practice Model for VTS and DLTC.

The proposal was presented at the MEC/MMC meeting held on Friday 09th June 2017 and a resolution was that the SLA's must be extended by 12 months only. In terms of the SLA; in the event that the agent wishes to accept the Head of Department's offer to extend or renew this Agreement, the agent shall give written notice of its acceptance of the Head of Department offer to extend or renew this Agreement no later than 30 (thirty) days after receipt of offer to extend or renew the agreement.

AND WHEREAS the Parties wish to revive and extend the duration of the agreement:


NOW THEREFORE THE PARTIES hereby agree as follows:

2. The Agreement is amended by extending the expiry date by a further period of twelve months to December 2018.
3. Reference to duration of the Agreement shall from signature of this addendum mean December 2018.




