#### Opening of Tenders:

Tenders will be opened in public at 12h00, on Wednesday, 09 February 2011, Room 9, Ground Floor, CNR Leslie and Beaconsfield Avenues, Vereeniging.

#### Bidders must take note of the following:

- Bids must only be submitted on the bid documentation provided by the Sedibeng District Municipality.
- Bids will be evaluated according to the 90/10 for preferential points system;
- Persons in the service of the state are not allowed to bid;
- Bidders are requested to submit two copies of the technical proposal and one copy of the financial proposal. Each copy must be clearly marked "copy" and "original";
- Bidders who are not registered on the supplier database of Sedibeng District Municipality are requested to obtain database forms at the cashier office. The forms must be submitted together with their proposals;
- Bidders should attach a Valid Tax Clearance Certificate, a valid certified CIDB certificate and an up to date Municipal rates statements. Failure to attach these documents will result to a tender being non-responsive; and
