BACKGROUND:

Sedibeng District Municipality is requesting bidders to submit tenders for the installation of network cabling and general repair and maintenance of the existing CAT6 network environment within the Sedibeng District on an ad hoc basis required at all existing and new sites by the successful bidder. The contract will run for a period of three years, renewed yearly. This contract will not be exclusive and will not bind the council to a sole supplier for the term

OVERVIEW OF THE CURRENT ENVIRONMENT

The Sedibeng District Council currently operates a large Wide Area Network that covers the geographical Municipal areas of Emfuleni, Lesedi and Midvaal. Various offices are present in this area, with the main office situated at corner Beaconsfield and Leslie Avenue's, Vereeniging.

Offices are cabled with either Cat5E or Cat6 network cabling and UTP points. Points are linked to manageable switches with a 10/100/1000 configuration. Brush panels, patch panels, patch and fly leads, cabinetry and labelling forms part of a standard installation.

Additional fibre cabling and connections are found in various buildings, linking to the main fibre network running throughout the District.

SPECIFICATION

- All cables are to be visually inspected for damage prior to installation

All items quoted on will be subject to the general installation practice requirements and special conditions of contract as stipulated in the tender document.

GENERAL INSTALLATION PRACTICE REQUIREMENTS

It is expected that installed products be capable of supporting voice and data communication applications and protocols from baseline 56Kbps to ISDN PRI for analog and digital voice and 10BaseT to 1000BaseT for data.

- The new cable will be pulled into the outlets and terminated at the floor UTP point
- All outlets will be tested and labeled clearly and to the satisfaction of the project manager
- Cable is not to be pulled in under excessive load
- Cable should be handled in such a way as not to damage the cable by means of kinks, twisting along its own axis, snagged etc.
- Whenever possible cable should be placed into pathways as opposed to pulled in under tension
- Care should be taken not to score conductors during the removal of the outer insulating sleeve of the cable when preparing to terminate pairs
- Cable bends are to be kept to a 25mm at minimum at all times
- During the installation process, the installer is required to visually inspect cable for damage. If such damage is found, cable needs to be replaced immediately
- All cabling must be clearly labeled at both ends
- All patch and workstation outlet cables shall be clearly labeled by means of an appropriately secured printed label
- Cable shall under no circumstance be strapped to PVC electrical conduit or any structures belonging to an unrelated functional unit such as an air conditioning drain pipe
- Conduit are to be used for structured cabling where ducting is unavailable or inappropriate
- All cables are to be made neat and fasted securely by means of appropriate fasteners, ducting or trays so as to ensure a sound and durable installation
- Care must be taken not to install cable near excessive heat sources as to avoid damage to the structure of the cable

Acceptance of these requirements are mandatory, no variation will be tolerated nor accepted and would lead to the immediately cancellation of the contract

GUARANTEES

All products quoted on should carry a full original manufacturer's guarantee.

Upon the receipt of an official order from Sedibeng District Municipality delivery and installation of the required products should be within **72 hours** from the issue of the order.

Repairs orders will be issued either via an official order or an emergency order – depending on the importance of the connection and repairs should be affected within **8 working hours** to ensure continuance of service delivery to end users.

In the event that delivery cannot take place within the specified time frame, the vendor is obliged to inform the Director: Information Technology in writing of the possible delay and on his discretion an extension will be granted or the order may be cancelled.

PRICE FLUCTUATIONS

Prices quoted will be reviewed on a year on year basis and will be compared with prices charged by registered networking vendors on our database.

ADJUDICATION

It is anticipated that the tender amount will not exceed R50, 000,000.00; therefore, it is advertised for adjudication on an 80/20 preferential pointing system.

Preference will be given to local based companies and to organizations that can submit a record of accomplishment in this field.

The evaluation criteria will consist of three sections, namely Technical evaluation, financial evaluation and Equity evaluation.

- Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
