PURPOSE

The Sedibeng District Municipality hereby request Service Providers to provide quotations for the transport of participants of the Gauteng Carnival to and from the Carnival on Sunday, 24 September 2017.

BACKGROUND

The Gauteng Carnival 2017 Theme is: **“CELEBRATING OUR LIVING HERITAGE: TREASURE THE YEAR OF OR TAMBO.”**

The Gauteng Carnival also aims to promote the importance of democracy and the empowerment and development of women and youth, recognizing the supreme sacrifices made by the forbearers’ in the struggle for freedom and liberty. Also, to inculcate the spirit of active citizenship through a civic education campaign emphasizing the “rights and responsibilities” of young people in Gauteng

The 2017 Gauteng Carnival will be hosted in the City of Tshwane. The drop off point for participants is at the Tshwane Events Centre in the City of Tshwane. The participants will then proceed with the Street Carnival. The pick-up point for participants will be at the at the Tshwane Events Centre.

INVOLVEMENT IN THE CARNIVAL

The Sedibeng District Municipality will provide transport to and from the venue by providing five (05) busses.

SCOPE OF WORK

The supply of five (05) busses to transport participants to the Gauteng Carnival at the Tshwane Events Centre at 205 Soutter Street in Pretoria Weston Sunday, 24 September 2017. Departure of busses from the bus depot must be at 06:00 and drop off at the Tshwane Events Centre must be no later than 10:00. Busses will depart from the Tshwane Events Centre form 15:00. Scope of work include:

- To transport participants from specified pick up points in the Sedibeng Region, to the Tshwane Events Centre at 205 Soutter Street in Pretoria West, and back to the respective drop off points, preferably in 65-seater busses.
- Members of the Regional Carnival Management Committee (CMC) will need access to the bus depot on the morning of the event from 05:00.
- Pick up times for participants will start from 06:00 on Sunday, 24 September 2017.
- Busses will depart from the Tshwane Events Centre at 205 Soutter Street in Pretoria West back to respective drop off points in the Sedibeng Region from 15:00.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and

1.2 The value of this bid is estimated not to exceed R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional Discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their Expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less .
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid Documents, of a service or commodity that is designed to be practical and useful, working or Operating, taking into account, among other factors, the quality, reliability, viability and durability of a Service and the technical capacity and ability of a bidder;
