PURPOSE

The Sedibeng District Municipality hereby request Service Providers to provide quotations for breakfast food packs for the participants of the Gauteng Carnival to and from the Carnival on Wednesday, 24 September 2015.

BACKGROUND

The Gauteng Carnival is the South African story with common themes based on folklore, culture, and stories from the people of Gauteng. The story is told in a street showcasing months of artistic preparation of colourful large, medium and small costumes, traditional dance and music. The Gauteng Carnival tradition is based on a number of disciplines including masquerade, traditional music and dance, house music and local dance.

Sedibeng District Municipality has been part of the Carnival initiative, participating and contributing positively towards the achievements of this objective. The main objective being bringing Youth, Artists and Designers together to be part of this growing prestigious event that takes place annually. The carnival has various programmes that contribute towards the development of artists and crafters in the region including the Puisano Jazz program, Battle of the DJs, Hip Hop Competitions, and a Dance Programme as part of the build up towards the annual Carnival. In past years the Sedibeng District Municipality has been supporting this initiative and contributed positively towards the development of the Creative Industries in the Sedibeng Region and Gauteng Province.

CARNIVAL THEME AND VENUE FOR 2015

The 2015 the Gauteng Main Carnival and Children's Carnival will be combined to celebrate 60 years of the Freedom Charter in South Africa. The 2015 Carnival theme is derived from the storyline that involve famous icons, historical events, political issues and other significant cultural events. The venue will be determined by the Gauteng Province Department of Sports, Arts, Culture and Recreation and will be in Tshwane.

INVOLVEMENT IN THE CARNIVAL

The Sedibeng District Municipality plans include the rural, white communities, Indians and Coloured communities as part of Nation building and Social Cohesion. The Gauteng Department of SACR expects the Sedibeng District Municipality to transport participants to and from the venue as well as provide breakfast food packs. The Sedibeng District Municipality will provide transport to and from the venue as well as breakfast food packs for 2000 participants.

SCOPE OF WORK

The supply of breakfast food packs for 2000 participants to the Gauteng Carnival on Wednesday, 24 September 2015. The specifications for the breakfast food packs are as follows:

- 1 X Ham and Cheese Sandwich (2 slices bread)
- 1 X 48 gram cereal bar (e.g. Oats Bar)
- 1 X 36 gram packet of chips
- 1 X fruit (Preferably apple. No bananas or other soft fruit as it spoils too easily)
- 1 X 500 ml 100 % Fruit Juice
- 1 X 500 ml Still Bottled Water

N.B! Food packs should be packed separately in strong containers that can be distributed to participants on the busses. Delivery specifications are as follows:

DELIVERY ADDRESS:

The food packs need to be delivered at the bus depot of the appointed service providers for the transport of the participants to the Gauteng Main Carnival.

DELIVERY TIME: 05:00 ON Wednesday, 24 September 2015

QUANTITY: 2000

DELIVERY SPECIFICATIONS:

The appointed Service Providers for the supply and delivery of the food packs will be briefed by the Sedibeng Carnival Management Committee (CMC) to inform on important matters. The Service Provider need to provide coordinators responsible for the different bus depots in order for CMC members to communicate directly with the responsible person. The Service Provider will be provided with the lists of participating groups and food packs should be divided into separate packs as per list. Delivery needs to be at the bus depots of the appointed transport companies. CMC members and assistants will then ensure that the packs are put on the busses before departure to the respective pick up points. This distribution need to be between 05:00 and 06:00 as pick up times will be from as early as 06:00 on Wednesday, 24 September 2015.

MINIMUM REQUIREMENTS

SDM will select the best service provider whose quotation is accompanied with the documents required as per the Sedibeng Procurement Policy e.g. Up to date utilities accounts, Valid Tax Clearance Certificates etc.

- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** Error! Bookmark not defined. means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less.
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.

- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
