6. Late, Telexed, faxed or emailed tenders will not be accepted.
7. The Council does not bind itself to accept the lowest or any tender, and reserves the right to accept any tender in whole or in part.
8. Persons in the service of the state are not allowed to bid.

In the event that you are awarded a tender the strict compliance with terms have to observed and in so doing within a period (3 days) (*after an order is issued) a confirmation letter must be forwarded by you in terms of which you need to indicate whether or not you will be in a position to source the items per the tender and deliver same by the due date.

SPECIFICATIONS: APPOINTMENT OF A SERVICE PROVIDER TO HOST AND CATER FOR 200 PEOPLE WITH DISABILITY.BID NO.:8/2/5/4-2015

1. PURPOSE

The purpose of this document is to seek an approval for a seven (7) tender to solicit a service provider to host 200 people with disabilities for two day HIV&AIDS and other social ills training (i.e providing accommodation also provide breakfast and lunch for 200 people). This emanate from the concerns raised by this sector during the Executive Mayor's Stakeholders IDP 2015-2016 workshop, that they are neglected and their plight is been trampled and compromised. The training is scheduled for the 20th and 21st August 2015.

2. BACKGROUND

The South African constitution states that "South Africa belongs to all who live in it; we are united in our diversity". The South African White Paper on an Integrated National Disability Strategy (INDS) envisions "A society for all...encompassing human diversity and the development of all human potential", encouraging people with disabilities (PWDs) to make contributions of their experience, capabilities and talents for national and international development.

Perception, fear and prejudice continue to limit understanding and acceptance of disability in the community and the world of work. Cultural myths and misconceptions appear to also play a role in disability discrimination, as some African cultures view disabled children as a social and economic curse on the family and are often considered a burden

Although South Africa has developed a number of policies with respect to fairness and equality of race, gender and disability in order to overcome segregation and discrimination; the real obstacle in South Africa still lies with the communities and employers marginalising people with disabilities.

Many employers are still hesitant to take on employees with disabilities because they believe they may create problems and/or under-perform, they are expensive and that these types of appointment incur costs as the workplace is forced to be disability-friendly. As a result many people with disabilities consider themselves to be without purpose. However, contrary to these notions, many companies still find that persons with disabilities are more than capable to perform most of the duties that are performed by everybody else.

3. DISCUSSION

Historically throughout different societies, people with disabilities have been discriminated against. This has varied from extinction and euthanasia to banishment and segregation, the vestiges of which create conditions of ignorance and prejudice towards people with disabilities. This marginalisation and ignorance also results in the systematic under-representation of people with disabilities in the key areas of social, economic and political life of any country. In particular, their access to education, employment as well as health and welfare services is severely restricted, resulting in widespread poverty and illness.

The South African Constitution embraces and supports disability and this is asserted by the participation of the country to the United Nation on the Rights of Persons with Disability and its Optional Protocol. The Preamble to our Constitution indicates our unwavering commitment to the attainment of social justice and the improvement of the quality of life for everyone. The Constitution declares the founding values of our society to be "human dignity, the achievement of equality and the advancement of human rights and freedoms." The Bill of Rights (Chapter 2 of the Constitution) highlights equality of all persons. It specifically mentions the right to equality and non-discrimination against persons on the grounds of disability (Section 9 (2-3)). These rights and values provide a solid rationale and basis for Local Government to prioritise the area of disability for action within their core mandate.

Therefore the district should be unwavering in the commitment to protect and promote the unalienable rights of people with disabilities to their full inclusion in all spheres of society, a quality life and developing to their fullest potential.

Therefore, the AIDS Directorate has lined up comprehensive training for as many as possible people with disabilities; starting with 200 of them. Training will also cover a variety of social ills that affect people with disabilities. This is also in line with HSRC 2014 report that shows concerning findings regarding people with disabilities, such as low condom use, low HIV&AIDS knowledge, women and children abuse and the others.

- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.

- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprisethat does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
