1. Purpose of the Event:

The purpose of this document is to outline the bid specifications to acquire the services of a providers, through a seven day tender process, to host the training workshop for 60 regional members of South African National Civic Association (SANCO) members on "Getting to HIV&AIDS 90-90-90 Target" in alignment with the National Strategic Plan, as outlined by the UNAIDS, as a new strategy to ameliorate the lives of people living with and affected by HIV and AIDS. The workshop is earmarked for the 11-13 December 2015.

1.1 BACKGROUND

In the South African History; the response to the AIDS epidemic shows a gradual apprehension of the magnitude of the problem of over two decades. The remaining difficult, although manageable problem is the continuous and consistent provision of appropriate management and care of this inherent chronic illness which has reached pandemic levels.

South Africa still remains the number one country with the highest number of adults living with HIV; at the same time the first country with unprecedented largest programmes that not only deal with but are effective in the mitigation of the scourge; from mother to child transmission to largest scale of HCT uptake, coverage and enrollment onto the ART programme.

DISCUSSION

In 2002, the "3x5" target to get three million people on treatment by 2015 was seen at least by some, as being over ambitious. But the target set the momentum to scale up. Although it took too long to achieve, by 2013 almost more than 15 million eligible people were on treatment.

The National launch of HCT by the president in 2011 also played a crucial part in encouraging people to know their HIV status and those HIV-negative to stay negative. The Global AIDS Conference in Melbourne in 2014 launched a new target, enroute to mitigating and finally eradicating AIDS; "The 90-90-90 Target". The target refers to three key steps that are essential to both better health and care for HIV-positive people and to limit new HIV-infection and subsequent spread. The target envisages that by 2020:

- 90% of all people living with HIV will know their HIV-status
- 90% of all people with diagnosed HIV infection will receive sustained antiretroviral therapy

• 90% of all people receiving antiretroviral therapy will have viral suppression.

SANCO is the primary and a fundamentally grounded forum that alludes and advocate for the needs of the community. Based on the concerns of SANCO that they have not, for some time now, being updated on the programmes and interventions of government regarding the mitigation of this scourge; they have requested, in line with the World AIDS Day commemorations, that they be updated on these strategies. It is therefore against this background that we plan to host them in a three day workshop to update them on the current trends, programmes and progress of government with regards to HIV&AIDS.

Score of 5: "EXCELLENT" A score of 5 will indicate that bidders have addressed all, or the vast majority of, points under each criterion, as well as demonstrating a deep understanding of the project. All solutions offered are linked directly to project requirements and show how they will be delivered and the impact that they will have on other areas and stakeholders. Proposals will contain novel or creative ideas which are realistic and which would enhance the service provision. To be awarded a score of 5, bids would exceed normal expectations and should clearly be seen as offering value added solutions.

Score of 4: "VERY GOOD" A score of 4 will reflect that bidders will have addressed in some detail all, or the majority of, the points listed under each criterion. Evidence will have been provided to show not only what will be provided but will give some detail on how this will be achieved. Bidders should make clear how their proposals relate directly to the aims of the project and be specific, rather than general, in the way proposed solutions will deliver the desired outcomes.

Score of 3: "AVERAGE" A score of 3 will again address the majority of the points under each criterion but will lack some clarity or detail in how the proposed solutions will be achieved. Evidence provided, while giving generic or general statements, is not specifically directed toward the aims and objectives of this project. Any significant omission of key information as identified under each criterion will point towards a score of 3.

Score between 1 and 2: "POOR TO BELOW AVERAGE" A score in this range will reflect that the bidder has not provided evidence to suggest how they will address a number of points under the evaluation criterion. Tenders will in parts be sketchy with little or no detail given on how they will meet project requirements. Evidence provided is considered weak or inappropriate and it is unclear how it relates to desired outcomes.

Score of 0: "VERY POOR" A score of 0 will result if no response is given or if the response is not acceptable and does not cover the required criteria.

The Financial Section of the quotation should be presented in such a way that each of the outputs and activities in the project implementation plan (based on what is in the ToR) are priced. A summary of these costs giving a total project price should be given at the end of the financial section of the quotation (the costs given should indicate exclusivity/ inclusivity of VAT.)
