1. PURPOSE

This Request for Quotations has been issued by the Sedibeng District Municipality (Sedibeng DM) in order to procure a service provider to deliver the project titled:

2. INTRODUCTION

The perimeter fencing at the Meyerton Vehicle Testing Station has deteriorated over the years and currently cannot be further effectively maintained. Certain sections of the fence are damaged. The replacement of a section of the fence has now become a necessity.

Sedibeng DM requires the services of an experienced Contractor to manufacture, supply and install a see through wire mesh fence for the Sedibeng DM at the Meyerton Vehicle Testing Station. Project completion should comply with all relevant legislation and best practice procedures.

3. PROJECT MANAGEMENT AND REPORTING

The Project Director will be the Executive Director: Transport, Infrastructure & Environment (or his nominee: the Project Manager) who will chair the Project Steering Committee (PSC) that will be set up to steer the project. The Service Provider will identify a member of their team as their Contract Manager. This person will be the client's primary contact point during the project.

In terms of project management there will be regular PSC meetings. For each of these meetings a brief status report will be submitted (in advance) by the Contract Manager, detailing progress against the project implementation plan. A format for such reports will be provided by the Sedibeng DM to the Service Provider. The Client will minute all PSC meetings.

4. PROJECT OBJECTIVE

The objective of Sedibeng DM is to upgrade sections of the existing perimeter fence with a 1,8m high Steel Wire Mesh Security fence as more fully described in the deliverables herein indicated below. The sections of the existing perimeter fence will be removed. A maintenance period of 12 months (retention period) will be applicable.

- Off Site Manufacturing of 1,8m Galvanised Steel Wire Mesh Fencing with Polymetic 6000 covering according to specification including delivery to site. The fence will be supplied and installed strictly according to details and specifications as indicated on Drawing **ZZ02/2016** which form part of this quotation. Castle type spikes will be included as a fence topping.

- Site establishment of service provider and compliance to OSH Act
- Management and supervision of project on and off site including management of local sub-contractors and/or local labour.
- Removal of and discarding of part of the existing fence as instructed.
- Erection of new steel wire mesh fencing where existing fence has been removed.
- Remove all construction spoil from site to Contractor's own dumping site.
- De-establishment of site.
- Maintenance of new fence during retention period.

The quotation submitted by a contractor, must be fully inclusive of all costs as detailed herein below.

Tendered Rates must include all overheads, materials, labour, mark-up, wastage, safety requirements, tools & equipment, overtime costs and any other cost the contractor might have to complete the work to an acceptable and workmanlike standard. Rates should therefore be fully inclusive. Contractor to allow for the protection of existing structures and services in the way or adjacent to proposed repair work.

Contractors must allow for work during normal hours with the requirements to minimize the disruption of the existing operational requirements of Sedibeng District Municipality's Meyerton VTS. Electricity will be supplied free of charge but any connections and electricity supply cables will be for the Contractor's account. Electricity supply to the contractor is however not guaranteed.

Preliminary quantities are indicated in the Bill of Quantities. Sedibeng DM however reserve the right to adjust quantities to comply with the available budget allowed for this project.

5. QUOTATION FORMAT AND CONTENT

The quotation must be accompanied by a detailed written submission of how the Service Provider will deliver the project under the following headings:

- Executive Summary of the deliverables as perceived by the Contractor and how he/she plans to execute the project with reference to main deliverables and benefits to the client.
- Proposed programme of work clearly indicating delivery timelines in days.
- Plant and equipment available/owned which will be used on the project.
- Plant and equipment to be hired or obtained for the project.
- Complete personnel structure of people directly involved in the project. Details of Site Agent's experience and qualifications.

- Work Plan that indicates minimal disruption to the Licensing operations.
