BACKGROUND:

The Municipal Complex, situated on the corner of Leslie and Beaconsfield Avenue, Vereeniging has several roof structures. One of the structures is a dome roof, covered in copper plating. The roof was vandalized and some of the copper plating was stolen.

PURPOSE:

The purpose of this tender is to appoint a suitably qualified and experienced contractor to remove all copper plating from the dome roof of the aforementioned building, to repair and clean the concrete surface, to affix roof seal and to paint the dome.

The copper plating which must be removed must be weighed and will be bought by the successful contractor from Sedibeng as scrap metal. Such price per kilogram must be indicated separately on the proposal. A representative of Sedibeng must accompany the contractor when scrap metal is weighed. The empty vehicle will be weighed at the Vereeniging Licensing center and when loaded will be weighed again to obtain weight of scrap metal.

- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;

- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.

5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.

5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
