3. Bids shall be sealed and endorsed (with bid number and bid description), and must be deposited at Sedibeng District Municipality's tender box (Ground Floor, outside the main building).
4. Sedibeng District Municipality's Supply Chain Management Policy shall apply.
5. Late, Telexed, faxed or emailed tenders will not be accepted.
6. The Council does not bind itself to accept the lowest or any tender, and reserves the right to accept any tender in whole or in part.
7. Persons in the service of the state are not allowed to bid.

In the event that you are awarded a tender the strict compliance with terms have to observed and in so doing within a period (3 days) (\*after an order is issued) a confirmation letter must be forwarded by you in terms of which you need to indicate whether or not you will be in a position to source the items per the tender and deliver same by the due date.

In the event that you do not furnish us with the said letter as requested and fail to comply as per the tender the Sedibeng District Municipality reserves in terms of rights to cancel this tender automatically after 3 days on the basis of you non-compliance and furthermore should you fail to deliver said goods which may necessitate the allocation of a new supplier the Sedibeng District Municipality may impose any further penalty or charges against you.

## SPECIFICATION:

### Proposal for Catering and décor for 500 VIP's for Human Rights Day on the 21 March 2018. Bid No.:8/2/5/2-2018

#### Background

The celebration of the Human Rights Day will be hosted by the National Department of Arts (SEE ANNEXURE A) and Culture in partnership with the Gauteng Provincial Government, Sedibeng District Municipality, VUT and other stakeholders. This commemoration will continue to acknowledge the significant role played by our Constitution which was signed in Sharpeville 22 years ago.

The concept plan covers all the build-up activities leading up to the commemoration of Human Rights Day in March 2018 and will encompass the celebration of the 22 years of the signing of the Constitution of the Republic of South Africa Act 108 of 1996. It also proposes a theme which has been consulted with the Provincial Department of Arts and Culture and outlines the tentative order of proceedings for the day. The 2018 Human Rights Day will be celebrated at George Thabe cricket pitch on the 21 March 2018. The build-up events for the 2018 Human Rights will be used to promote National Identity and accelerate the fight against racism in order to achieve a socially cohesive society within the city region. The theme will further emphasize the role played by the Honourable Nelson Mandela and Albertiba Sisulu in uniting the people of South Africa.

Noting the role played by Nelson Mandela and Albertiba Sisulu through correspondence with a number of overseas sympathisers after the Sharpeville Massacre, on 21 March 1960, we are deemed to recognize them during Human Rights month.
