CONDITIONS OF TENDER

3. Bids shall be sealed and endorsed (with bid number and bid description) and must be deposited at Sedibeng District Municipality's tender box (Ground Floor, outside the main building).
4. Sedibeng District Municipality's Supply Chain Management Policy shall apply.
5. Late, Telexed, faxed or emailed tenders will not be accepted.
6. The Council does not bind itself to accept the lowest or any tender and reserves the right to accept any tender in whole or in part.
7. Persons in the service of the state are not allowed to bid.

In the event that you are awarded a tender the strict compliance with terms have to observed and in so doing within a period (3 days) (*after an order is issued) a confirmation letter must be forwarded by you in terms of which you need to indicate whether or not you will be in a position to source the items per the tender and deliver same by the due date.

PURPOSE

The purpose of this tender is to obtain a service provider who will supply, service, repair and maintain the fire extinguishing equipment of Sedibeng District Municipality at all its various sites, fleet vehicles and buildings for a period of three years. Subject to annual performance review and budget availability.

BACKGROUND

Sedibeng currently has in excess of 30 buildings and sites where fire extinguishers are situated. The extinguishers include dry chemical powder type, water and foam type, CO2 gas type, hydrants and hose reels. There are currently in excess of 400 fire extinguishing equipment in all sites and buildings of Council. A summary of the types of equipment at Sedibeng sites is attached hereto as Annexure "A". Government regulations require fire equipment and systems to comply with a standard of performance and to be regularly tested, serviced and maintained.

SCOPE OF WORK

The successful contractor will be required to attend to all servicing, repairs and supply of fire extinguishing equipment at all buildings and sites and fleet vehicles of Council by:

- 3.1. Compiling a register listing all fire extinguishing equipment in Sedibeng per site by type and showing relevant service dates of equipment;
- 3.2. Periodically servicing all extinguishing equipment;
- 3.3. Supplying new fire extinguishing equipment when needed;
- 3.4. Compiling and maintaining of fire registers per site; and
- 3.5. Issuing the relevant compliance certificates per site.

TECHNICAL REQUIREMENTS

The following is expected of service providers bidding for this contract, and must be indicated on the bidding document with the relevant proof/supporting documents where necessary:

- 4.1. Have a minimum of four (4) service vehicles in fleet;
- 4.2. Have a maximum turn-around time of 24 hours after receipt of official order/instruction from Sedibeng;
- 4.3. Be able to do onsite maintenance and service on all equipment except CO² extinguishers;
- 4.4. Service provider must show ability to supply, service, repair, maintain and fill where necessary the following firefighting equipment, relevant supporting documentation/photographic evidence to be attached to tender:
 - Water and foam type extinguishers;
 - Dry powder extinguishers;
 - CO² gas extinguishers;
 - Fire hose reels; and
 - Fire hydrants.
- 4.5. Service provider must be equipped to do the following, relevant supporting documents/proof to be attached:
 - Hydrostatic tests on CO² cylinders; and
 - Pressure testing on equipment/cylinders.
- 4.6. Service provider must provide at least three (3) contactable references for similar work done on a similar scale in the past three (3) years.

MINIMUM REQUIREMENTS OF TENDER
