1. BACKGROUND

The Sedibeng District Municipality seeks to appoint suitably qualified contractor/s to provide hygienic and sanitation services to all Sedibeng District Municipality buildings and sites.

2. CONTRACT OBJECTIVES, ASSUMPTIONS AND RISKS

The project aims to provide a safe and healthy work environment to all the municipal employees, including all councillors and visitors, as well as the public at large, when they utilize the municipality's facilities. Project requirements to mitigate against hazards to safe and healthy conditions must comply with the provision of the Occupational Health and Safety Act (OHS), No 85 0f 1993 as amended. Non-compliance to the provision of the OHS Act and failure to implement relevant initiatives, including programmes and mechanisms to mitigate against hazards to safety and health may result in the municipality incurring claims for damages to property and for injury to persons.

The municipality believes that these interventions will prevent and manage diseases, injuries and other health conditions and improve health and quality of life through the prevention and treatment of diseases and other physical health and safety conditions through surveillance of cases and the promotion of healthy behaviour. This municipality retains the right, in the event of any unforeseen circumstances occurring, not to proceed with the actual project.

3. SCOPE OF WORK

The sanitation services are required by the Sedibeng District Municipality in order, amongst others issues, to keep the municipal buildings and sites hygienically clean. The scope of work, not limited to include supply and maintenance of all municipal buildings and sites, washrooms, toilets, storerooms, offices, halls and other sites, as per the schedule attached hereto as follows:

- Annexure "A" Part A Ablution Services;
- Annexure "B" Part B Hygiene rental and service.

4. MINIMUM REQUIREMENTS

- Up to date utility account e.g., Municipal Rates & Taxes account or A Valid Lease Agreement (Please note that if the Water and Lights statement is not in the company's name, kindly submit a lease agreement between the company and the landlord)

 - Estimated time of full installation at all sites.
 - Maximum response time for service requests during contract period.
 - Periodical service or upgrade plans for equipment.
- 5.8 Fitment / Installation of equipment to be included in tender amount.
- 5.9 Prices for Hot air dryers must include installation and electrical connection.
- 5.10 All electrical installations to be done by qualified electrician and COC to be submitted after installations.

6. SPECIAL CONDITIONS

6.1. Environment:

Preference will be given to Supplier/s, whose product offerings are "Green and environmentally friendly" and water soluble, with hygienic waste being disposed in an environmentally friendly method.

6.2. <u>SABS</u>

The cleaning products must have SABS certification including MSDS reports, it must be safe and adhere to environmentally green water soluble offerings. The manufacturing company of the cleaning product must be SABS approved and certified. Tenderer must include in the submission SABS - SANS 1853, SANS 1344 certificates of testing for the cleaning products. The cleaning product must be classed no worse than as an irritant by SABS. The hand soap/gel must have an MSDS report and be a rapid drying product that includes a product that stops skin dryness, kill bacteria, yeast and moulds rapidly. The product must not remove oils from skin. Please include reports which proofs this.

6.3. ISO 9000 Certification
